ANNOUNCEMENT

TRANSFER OF SHARES BETWEEN SUBSTANTIAL SHAREHOLDERS

This is a voluntary announcement made by EPI (Holdings) Limited (the “**Company**”).

SHARES TRANSFER

The board of directors of the Company (the “**Board**”) was notified by Climax Associates Limited (“**Climax**”) that on 28 May 2010, Climax transferred 21,246,000 shares in the Company to Mr. Wong Chi Wing Joseph (“**Mr. Wong**”), the Chairman and CEO of the Company (the “**Shares Transfer**”). Climax is owned as to 28.17% by Mr. Chu Kwok Chi Robert, an executive director of the Company and 71.83% by Rich Concept Worldwide Limited, which in turn is a company beneficially wholly-owned by Mr. Wong. Both Climax and Mr. Wong are shareholders of the Company holding direct interest of 1,219,966,000 and 9,000,000 shares of the Company respectively, representing approximately 11.06% and 0.08% of the issued shares of the Company respectively, immediately before the Shares Transfer. After the Shares Transfer and as at the date of this announcement, Climax and Mr. Wong each holds direct interest of 1,198,720,000 and 30,246,000 shares of the Company respectively, representing approximately 10.86% and 0.28% of the issued shares of the Company respectively.

The Board has been informed by Mr. Wong that he wishes to increase his direct interest in the Company and may acquire additional shares of the Company from Climax in the future, and that Climax together with parties in concert with it do not have any present intention to reduce their shareholding stake in the Company.
